2017-1-E Dennis moved and Brian seconded to add to the by-laws Article III section e "Current employees of the Wallkill Public Library are not eligible for election to the board of trustees, nor are they eligible for appointment to the board in the event of a vacancy. Eligibility resumes upon end of employment provided former employee meets eligibility criteria stated within these by-laws. Additionally, current board members are not eligible to be employees of the library." Motion passed.
